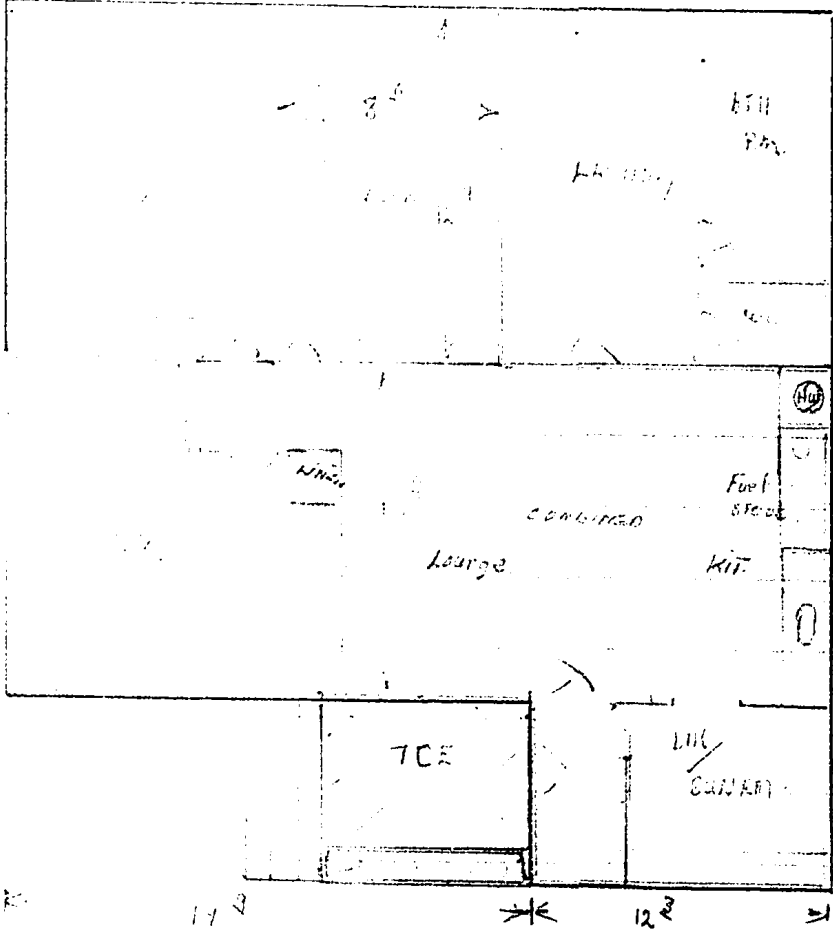

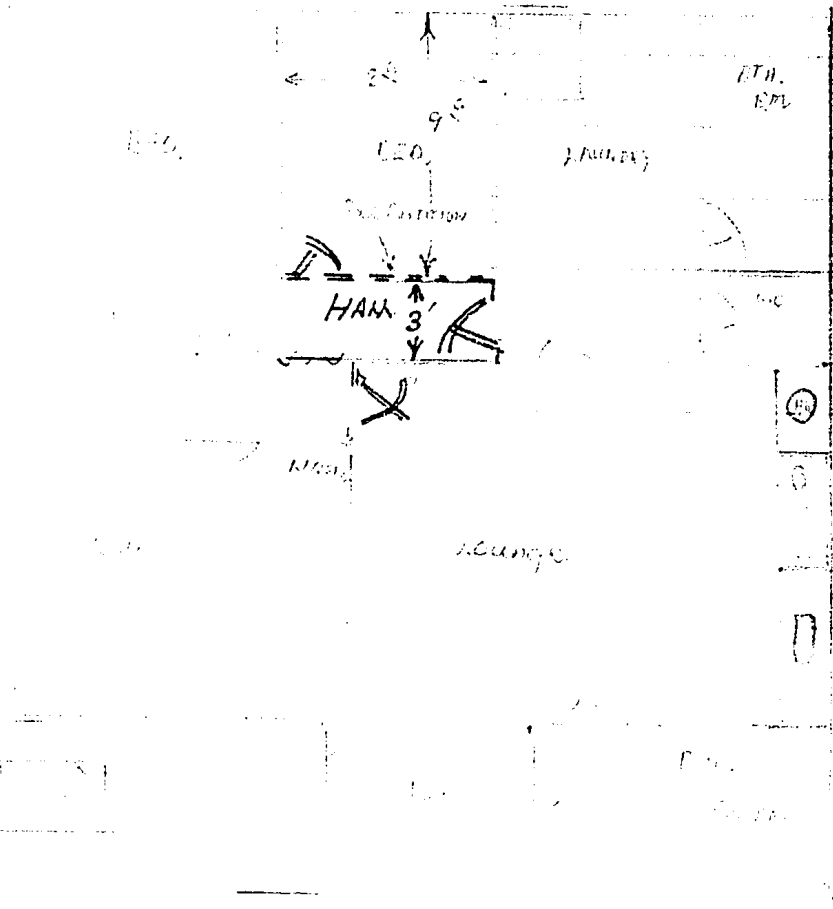

HOUSE CONNECTION PLAN

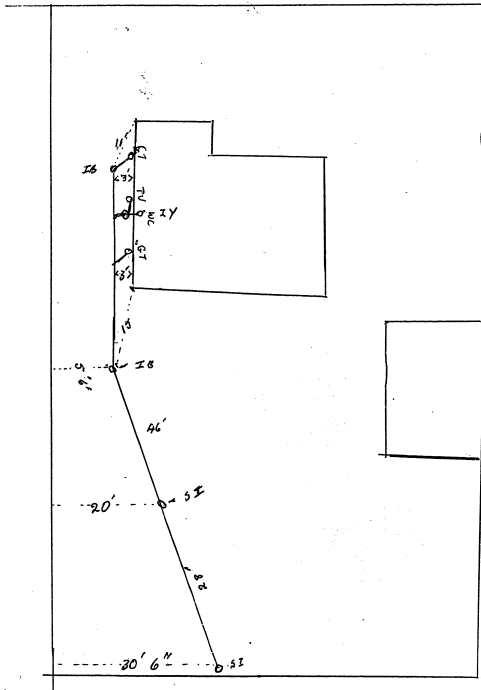

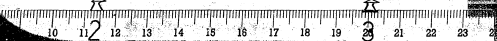
